

Privacy Policy

Hayman Quantrill Ltd is committed to protecting your privacy and developing technology that gives you the most powerful and safe online experience. This Statement of Privacy applies to the Hayman Quantrill Ltd site and governs data collection and usage. By using the Hayman Quantrill Ltd site, you consent to the data practices described in this statement.

Collection of your Personal Information

Hayman Quantrill Ltd collects personally identifiable information, such as your email address, name, home or work address or telephone number. Hayman Quantrill Ltd also collects anonymous demographic information, which is not unique to you, such as your ZIP code, age, gender, preferences, interests and favorites.

There is also information about your computer hardware and software that is automatically collected by Hayman Quantrill Ltd. This information can include: your IP address, browser type, domain names, access times and referring website addresses. This information is used by Hayman Quantrill Ltd for the operation of the service, to maintain quality of the service, and to provide general statistics regarding use of the Hayman Quantrill Ltd site.

Use of your Personal Information

Hayman Quantrill Ltd collects and uses your personal information to operate the Hayman Quantrill Ltd Web site and deliver the services you have requested. Hayman Quantrill Ltd also uses your personally identifiable information to inform you of other products or services available from Hayman Quantrill Ltd and its affiliates. Hayman Quantrill Ltd may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered.

Hayman Quantrill Ltd does not sell, rent or lease its customer lists to third parties. Hayman Quantrill Ltd may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address,

telephone number) is not transferred to the third party. In addition, Hayman Quantrill Ltd may share data with trusted partners to help us perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. All such third parties are prohibited from using your personal information except to provide these services to Hayman Quantrill Ltd, and they are required to maintain the confidentiality of your information.

Hayman Quantrill Ltd does not use or disclose sensitive personal information, such as race, religion, or political affiliations, without your explicit consent.

Hayman Quantrill Ltd keeps track of the Web sites and pages our customers visit within Hayman Quantrill Ltd, in order to determine what Hayman Quantrill Ltd services are the most popular. This data is used to deliver customized content and advertising within Hayman Quantrill Ltd to customers whose behavior indicates that they are interested in a particular subject area.

Hayman Quantrill Ltd Web sites will disclose your personal information, without notice, only if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Hayman Quantrill Ltd or the site; (b) protect and defend the rights or property of Hayman Quantrill Ltd; and, (c) act under exigent circumstances to protect the personal safety of users of Hayman Quantrill Ltd, or the public.

Use of Cookies

The Hayman Quantrill Ltd Web site use "cookies" to help you personalize your online experience. A cookie is a text file that is placed on your hard disk by a Web page server. Cookies cannot be used to run programs or deliver viruses to your computer. Cookies are uniquely assigned to you, and can only be read by a web server in the domain that issued the cookie to you.

One of the primary purposes of cookies is to provide a convenience feature to save you time. The purpose of a cookie is to tell the Web server that you have returned to a specific page. This simplifies the process of recording your personal information, such as billing addresses, shipping addresses, and so on. Security of your Personal Information

Hayman Quantrill Ltd secures your personal information from unauthorized access, use or disclosure. When personal information (such as a credit card number) is transmitted to other Web sites, it is protected through the use of encryption, such as the Secure Socket Layer (SSL) protocol.
